POSITION PURPOSE

As the Draper, you are a theatrical craftsperson responsible for the construction and preparation of all assigned production costumes.

POSITION FUNCTIONS AND RESPONSIBILITIES

PRIMARY RESPONSIBILITIES

- Use the sketch provided by the Costume Designer to create the costume.
- Fabricate patterns, either by draping or flat pattern making, for specific actors and fit the costume to the actor.
- Cut or supervise the cutting of all the fabric for the costume from the pattern and determine yardage for fabric and trim for the costume including stock fabrics.
- Supervise Stitchers and advise on methodologies for made-to-order garments and fitting alterations.
- Perform complex sewing and tailoring.
- Keep a record of show fabrics and yardages.
- Correct patterns or alter costumes as necessary and supervise a crew by preparing and delegating work to First Hands and Stitchers.
- Manage time, including that of any crew member in an effective manner.
- Research period, style, and techniques necessary to complete the costume within the Costume Designer's guidelines.
- Maintain the integrity of the Costume Design through his/her interpretation of the sketch.
- Sit with the designer at dress rehearsals as assigned.
- Maintain your personal work area, including sewing machinery, cutting table, and bulletin boards as necessary to keep work moving effectively and to promote a professional environment.
- Maintain inventory of sewing supplies and fabrics and communicate needs in a timely manner.
- Attend weekly shop meetings and consult with other team members, co-workers, and Costume Shop Manager concerning problems and their possible solutions.
- Talk with visitors and tour groups as needed.
- Perform other duties such as pulling, restocking, and maintenance.
- Perform such tasks, services, duties, and responsibilities in accordance with UFOMT policies, rules, regulations, and instructions now in force or which may be adopted from time to time during Employee's employment at the UFOMT.

OTHER FUNCTIONS

- Other duties as determined by Costume Director and Production Manager.

EDUCATION AND/OR EXPERIENCE

To perform this job successfully, an individual must have the following education and/or experience.

- 3-5 years experience as a draper or advanced degree in costume technology
- Experience supervising teams
- Ability to work in a team and maintain a positive attitude.
- Ability to collaborate with fellow staff and freelance artists.
- Experience cutting out patterns and manipulating fabric

KNOWLEDGE, SKILLS, AND ABILITIES

The requirements listed below are representative of the knowledge, skills, and/or abilities required to perform each essential duty satisfactorily. We will make reasonable accommodations to enable individuals with disabilities to perform these functions.

- In-depth knowledge of a variety of periods and styles of costuming
- Proficiency in manipulating fabric
- Proficiency in operating costume-related machinery
- Ability to work occasional nights and weekends.

PHYSICAL DEMANDS

The physical demands described here are representative of those an individual must meet in order to successfully perform the essential functions of this job. We will make reasonable accommodations to enable individuals with disabilities to perform these functions.

- This position frequently communicates with groups of people in open areas
- This position assists in observing and judging garment finish from the theatre seats
- This position frequently operates costume machinery
- This position works in a stationary position for 50% of the time or more.
- Occasionally ascends/descends stairs/work ladders
- Occasionally will work outside to load or unload costume elements to/from vehicles
- Ability to transport 20 pounds of costumes
