POSITION PURPOSE

The Craft Artisan is a theatrical craftsperson responsible for the creation and execution of costume crafts. This includes all accessories and specialty pieces as specified by the Costume Designer and/or Costume Director including but not limited to the dying and painting of fabrics, as well as the construction of items like hats, belts, and shoes.

POSITION FUNCTIONS AND RESPONSIBILITIES

PRIMARY RESPONSIBILITIES

- Create accessory and specialty pieces as designed
 - o this includes but is not limited to hats, jewelry, footwear, armor, foam structures, mechanical costumes, puppets, masks, belts, fans, and purses
- Fabricate patterns as needed
- Complete fittings for all accessory and specialty pieces.
- Keep records of materials needed to complete pieces.
- Maintain the integrity of the Costume Design through his/her interpretation of the sketch.
- Assist in pulling as needed and sit with the designer at technical rehearsals and previews as assigned.
- Maintain your personal work area, including sewing machinery, cutting table, and bulletin boards as necessary to keep work moving effectively and to promote a professional environment.
- Perform other duties such as pulling, restocking, and maintenance.
- Perform such tasks, services, duties, and responsibilities in accordance with UFOMT policies, rules, regulations, and instructions now in force or which may be adopted from time to time during Employee's employment at the UFOMT.

OTHER FUNCTIONS

• Other duties as determined by Costume Director and Director of Production.
